



GENERAL NOTES:

- CONTRACTOR SHALL KEEP THE SITE OPEN AND ACCESSIBLE TO THE GENERAL PUBLIC DURING THE CONTRACT, WITH EXCEPTION OF THE TIME REQUIRED TO RESURFACE THE WELCOME CENTER ENTRANCE AND EXIT RAMPS FROM AND TO THE INTERSTATE. THE CONTRACTOR SHALL PROVIDE THE NECESSARY PEDESTRIAN BARRICADES, SURROUNDING THE ENTIRE WORK AREA, TO ROUTE THE GENERAL PUBLIC AROUND THE WORK AREAS IN ACCORDANCE WITH MUTCD (MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES - LATEST EDITION). BARRICADES SHALL CONSIST OF KEYSTONE (OR APPROVED EQUAL) RED BRAND STUDDED T-POSTS (FENCE POSTS), GREEN, 6'-0" LONG, 10'-0" O.C.; TYPE III BARRICADES FOR TRUCK PARKING, TENEX (OR APPROVED EQUAL) ORANGE SAFETY FENCE, 4'-0" HIGH, SECURE WITH ALUMINUM FENCE TIES OR TIE WIRE. FLOURESCENT ORANGE SHEETING SHALL BE REQUIRED FOR CONSTRUCTION AND TRAFFIC CONTROL SIGNS.
- EXISTING STRUCTURES OR UTILITIES, NOT DESIGNATED FOR DEMOLITION/UPGRADE, DAMAGED BY THE CONSTRUCTION OPERATION, AS DETERMINED BY THE ENGINEER, SHALL BE REPLACED OR REPAIRED BY THE CONTRACTOR, AT NO COST TO THE DEPARTMENT.
- THE BRICK AND MORTAR FOR THE CONSTRUCTION OF THE WELCOME CENTER SIGN SHALL BE THE SAME TYPE AND KIND AND SHALL MATCH THE EXISTING BRICK USED ON THE BUILDING, OR APPROVED EQUAL. THE BRICK WILL NOT REQUIRE TESTING, BUT REQUIRES APPROVAL OF THE ENGINEER.
- THE CONTRACTOR WILL BE PERMITTED TO USE WATER THAT IS AVAILABLE ON THE SITE DURING THE PLANTING AND ESTABLISHING OF THE TREES AND SHRUBS. FALLEN LIMBS, LITTER AND DEBRIS SHALL BE REMOVED FROM THE SITE FOR THE LIFE OF THE CONTRACT. THE CONTRACTOR SHALL PROVIDE TREE PROTECTION DURING CONSTRUCTION.
- IF THE CONTRACTOR, IN THE COURSE OF THE WORK, FINDS OR SUSPECTS ANY DISCREPANCY BETWEEN THE DRAWINGS AND THE PHYSICAL CONDITIONS OF THE SITE OR WORK OR ANY ERRORS OR OMISSIONS IN THE CONTRACT DOCUMENTS OR SPECIFICATIONS, HE SHALL IMMEDIATELY NOTIFY THE ENGINEER, AND THE ENGINEER SHALL PROMPTLY VERIFY THE SAME. ANY WORK DONE AFTER SUCH DISCOVERY, UNLESS AUTHORIZED, SHALL BE DONE AT THE CONTRACTOR'S RISK.
- DURING CONSTRUCTION, WHILE WELCOME CENTER IS OPEN, CONTRACTOR SHALL PROVIDE BARRIER FREE, ALL-WEATHER SURFACE ACCESS FROM THE VEHICULAR PARKING AREA TO THE WELCOME CENTER BUILDING. PLYWOOD WALKS WITH SLIP RESISTANT FINISH WITH ENGINEERS APPROVAL.
