Bidders are hereby advised that lane closure restrictions and work restrictions on the above captioned project shall be as follows:

**Sunday** -- Work can begin at 7 PM, and lane closures will be allowed until 6 AM Monday.

**Monday through Thursday** -- No lane closures shall be allowed between the hours of 6 AM and 7 PM. Thursday night work shall be considered to end at 6 AM on Friday.

**Friday and Saturday** – Friday night work and Saturday night work shall not be allowed on the project, except for the specific areas identified in the contract. Work that does not require a lane closure shall be allowed on Friday and Saturday. However, a lane closure shall be allowed on Saturday from 6 AM until 11 AM.

The above lane closure restrictions apply to interstate routes only. Lane closures for non-interstate work will be allowed Monday through Saturday between 9:00 AM and 4:00 PM. In cases where a loop or ramp has to be completely closed to accomplish the work, that work will have to be done on Monday through Thursday night adhering to the restrictions above.

No exceptions to the above requirements will be allowed unless specifically allowed by the Engineer.

Also, no lane closures will be permitted on the following holidays or the day preceding them: New Year's Day, Independence Day, Labor Day, Thanksgiving Day or Christmas Day. In the event that one of the above mentioned holidays falls during the weekend or on a Monday, no lane closures will be allowed during that weekend or the Friday immediately preceding that holiday.

If the lane closure restriction listed above is violated, no excuses will be accepted by the Department and the Contractor will be charged a fee of **\$ 2,500.00** for each full or partial five minute period until the roadway is back in compliance with the lane closure restriction requirement.

For the purposes of this contract, official time shall be the announced time available at the Jackson area telephone number (601) 355-9311.
