





GENERAL NOTES:

1. THE CONTRACTOR SHALL MAKE A MISSISSIPPI ONE-CALL REQUEST PRIOR TO ANY EXCAVATION OPERATION.
2. IN ORDER TO EXPEDITE THE SAFE MOVEMENT OF TRAFFIC AND TO PROTECT EACH PHASE OF THE WORK AS IT IS PERFORMED, A FIRM SEQUENCE OF OPERATIONS IS ESSENTIAL. THE WORK SHALL BE BEGUN AND CONTINUALLY PROSECUTED.
3. THE CONTRACTOR SHALL PROVIDE ALL SIGNS AND TRAFFIC HANDLING DEVICES NECESSARY TO SAFELY MAINTAIN TRAFFIC AROUND OR THROUGH THE WORK AREAS.
4. INCIDENTAL WORK SUCH AS REMOVING VEGETATION AND OTHER INCIDENTAL WORK THAT IS NECESSARY TO COMPLETE THE WORK WILL NOT BE MEASURED FOR SEPARATE PAYMENT AND THE COST WILL BE INCLUDED IN THE ITEMS BID.
5. IT SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR TO PROTECT THE ROADWAY AND ALL EXISTING STRUCTURES SUCH AS BRIDGES, CURBS AND OTHER FEATURES FROM DAMAGE DURING CONSTRUCTION. THE CONTRACTOR SHALL REPLACE OR REPAIR, AS DIRECTED BY THE ENGINEER, ANY STRUCTURES OR PORTION OF THE ROADWAY DAMAGED AS A RESULT OF CONTRACTOR'S OPERATIONS DURING THE LIFE OF THE CONTRACT. NO PAYMENT WILL BE MADE FOR REPLACEMENT OR REPAIR OF DAMAGED ITEMS, CAUSED BY THE CONTRACTOR'S OPERATIONS.
6. FLUORESCENT ORANGE SHEETING SHALL BE USED ON ALL CONSTRUCTION AND TRAFFIC CONTROL SIGNS EXCEPT FOR THOSE DESIGNATED IN PLANS TO BE BLACK LEGEND AND BORDER ON WHITE BACKGROUND.
7. DURING PERIODS OF WORK WHERE A LANE CLOSURE IS NOT REQUIRED THE CONTRACTOR SHALL HAVE IN PLACE AS A MINIMUM REQUIREMENT W20-1, AS SHOWN ON TCP-1.
