Bidders are hereby advised that sealed bids will be received by the Mississippi Transportation Commission in the First Floor Auditorium of the Mississippi Department of Transportation Administration Building in Jackson, Mississippi until 10:00 o'clock A.M., Tuesday, June 23, 2009 for projects listed in the June Advertisement. **Only bids received by 10:00 o'clock A.M., Tuesday, June 23, 2009 will be accepted.** Bids will be held in sealed condition at a secure location until the morning of the bid opening. The opening of these bids will be postponed until **June 30, 2009**, provided the MDOT Budget has been approved by the Mississippi Legislature. If the MDOT Budget has not been approved by June 30, 2009, the opening of the bids for the June Letting will be postponed until 10:00 o'clock A.M on the first Tuesday following the approval of the MDOT Budget.
