Traffic will be allowed on the leveling lift and the surface lift of $1\frac{1}{2}$ " of 9.5-mm, MT, HMA/WMA, will be placed under traffic.

Bidders are advised that the milling depth at county roads from Station 228+36 to 519+50 shall be 1½" and shall be overlaid with 1½" of 9.5-mm, MT, HMA/WMA mix. The limits of the 1½-inch milling are as shown on the County Roads detail from the edge on the 28-foot mainline pavement width to the End of State Maintenance.
