

When a DBE goal is contained in the contract, the award will be contingent upon the Contractor satisfying the DBE requirements.

Proposals are available at a cost of Ten Dollars (\$ 10.00) per proposal plus a small convenience fee. Cash or checks will not be accepted as payment.

Bid bond, signed or countersigned by a Mississippi Agent or Qualified non-resident agent, with Power of Attorney Attached, a Cashier's Check or Certified Check for five (5%) percent of bid, payable to STATE OF MISSISSIPPI, must accompany each proposal.

The attention of bidders is directed to the provisions of Subsection 102.07 pertaining to irregular proposals and rejection of bids.
