Bidders are advised that the scope of work in the proposal does not include Temporary Stripe pay items. Bidders are further advised that the quantities in the bid items include enough Removal of Traffic Stripe and Temporary Stripe items to remove all existing stripe and replace with temporary stripe on the entire project for one application. **However, stripe at each site will be evaluated at the time of construction. In areas where existing stripe is worn down and the Engineer determines that it can be recapped, Removal of Traffic Stripe and Temporary Stripe will not be required.** Additionally, if the Contractor elects to phase work in such a way that Thermoplastic Stripe can be applied immediately after Removal of Stripe, Temporary Stripe will not be required.
