Bidders are hereby advised of the following change to the plans:

Bidders shall disregard the General Note #12 on sheet GN-1 and the following note shall take its place:

Traffic will be allowed to run on a milled surface for up to five (5) calendar days. The Contractor will be assessed a penalty of **\$5,000 per calendar day** for each day exceeding the allotted 5 days until the roadway is back in compliance. Lane closures within the restricted times will not be allowed as a means to avoid the penalty. It shall be the Contractor's responsibility to ensure that milling operations do not commence until such time that forecasted weather conditions will allow placement of the asphalt pavement subsequent to the milling operations.
