- (2) ALL TRAFFIC CONTROL DEVICES ON THIS PROJECT SHALL COMPLY WITH THE MUTCD (LATEST EDITION). MISLEADING DEVICES SHALL BE REMOVED, DISCONNECTED AND OR COVERED WHEN NOT IN USE UNLESS OTHERWISE NOTED. ANY DEVICES WHICH ARE DAMAGED DUE TO CONSTRUCTION SHALL BE REPLACED AT THE CONTRACTOR'S EXPENSE.
- (3) ALL PLASTIC DRUMS SHALL HAVE A BALLASTING COLLAR MADE FROM RECYCLED TRUCK TIRES OR OTHER SUITABLE MATERIAL.

- (10) ALL LANE CLOSURES APPROVED BY THE PROJECT ENGINEER SHALL TAKE PLACE AT NIGHT SUNDAY THRU THRUSDAY, AND BETWEEN 7:00 P.M. AND 5 A.M..
- (11) ALL LANES SHALL BE MAINTAINED CONTINUOUSLY AT THOSE TIMES THAT CONSTRUCTION IS NOT IN PROGRESS.
- (12) CONTRACTOR SHALL PROVIDE ONE WEEK ADVANCE NOTICE OF LANE CLOSURES TO THE PUBLIC THROUGH VARIOUS MEDIA OUTLETS AND CHANGEABLE MESSAGE SIGNS. CONTRACTOR SHALL STRICTLY ADHERE TO THE PUBLICIZED DATES/HOURS OF CLOSURE.
