**SUBJECT: Asphalt Density Requirements**

**PROJECT: MP-1025-48(011) / 306071301, 302, & 303 – Monroe County**

Bidders are advised that in lieu of the asphalt density requirement addressed in Section 401 and 403, the following shall be used in determining asphalt densities from **Station 10+00 to Station 68+82.**

The density requirement for asphalt shall be roll to refusal. Refusal is defined as the number of roller passes to maximize the in-place unit weight of the mixture. On the first day of production and every three production days thereafter, a 500-foot test strip shall be evaluated to determine the required number of roller passes. Three random sites within the test strip shall be selected and monitored with the nuclear density gauge to determine refusal.
