Bidders are hereby advised that lane closure restrictions on the above captioned project shall be as follows:

Monday through Friday: -- Lane closures will NOT be allowed between the hours of 6:00 AM and 8:30 AM & 4:00 PM and 6:00 PM within the project limits.

No exceptions to the above requirements will be allowed unless specifically approved by the Project Engineer.

No lane closures will be permitted on the following holidays or the day preceding them: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day or Christmas Day. In the event that one the above mentioned holidays falls during the weekend or on a Monday, no lane closures will be allowed during that weekend or the Friday immediately preceding that holiday.

If the lane closure restriction listed above is violated, no excuses will be accepted by the Department and the Contractor will be charged a fee of \$500.00 for each full or partial five minute period until the roadway is back in compliance with the lane closure restriction requirement.
