The wording in the third paragraph of Notice to Bidders No. 2 (Status of Right-of-Way, Utility Adjustments and Potentially Contaminated Sites) does not apply to the restrictions contained in this Notice to Bidders. The Notice to Proceed will be issued with the following restrictions:

The Contractor shall not occupy the right-of-way listed below until clearance has been obtained:

US 11 from Station 317+00 to Station 383+60.

SR 43 from Station 84+00 to Station 87+50.

The above listed areas of the project will be restricted until **January 31, 2020**. It is not anticipated that the restricted access to this section of the project will materially affect the progress of the work unless delayed past this date.

No extension of time will be considered for this non-access unless restrictions extend beyond the above mentioned date. If conditions permit, the Contractor will be allowed earlier access without a penalty in contract time.
