Bidders are hereby advised that lane closures for construction operations will not be allowed during the hours of 6:30 AM to 8:30 AM and 4:00 PM to 6:00 PM Monday through Friday.

No lane closures will be allowed on days when Football games are played at The University of Mississippi. If these games occur on a Saturday, no work will be allowed the Friday proceeding the game. Otherwise, if the game is on any day other than Saturday, the work restrictions will only apply to the day of the game.

No exceptions to the above requirements will be allowed without written approval by the Engineer. Also, construction activities will be conducted as per section 108.04 of the 2017 Standard Specifications. If any of the work restrictions listed above are violated, the Contractor will be charged a fee of **\$125.00** for each full or partial five minute period until the roadway is back in compliance with the work restrictions listed above.
