Bidders are hereby advised that the Contractor shall notify the Project Engineer and local officials 30 days prior to closing the roadway.

The Bidder's attention is also called to Working Number DCS-2, Sheet No. 26 entitled "Detail of Construction Signing" sheet in the plans. Changeable Message Signs shall be placed in accordance with the locations and times prescribed on this sheet.

Bidders are hereby advised that the once Site 1 (Bridge No. 4.1) has been closed to traffic, all work necessary to reopen Site 1 (Bridge No. 4.1) shall begin. The Contractor shall continue without interruption until the site has been reopened. If for any reason, the Contractor discontinues work at Site 1 (Bridge No. 4.1), all other work on the project shall cease until work resumes in this area.

Simultaneous work in other locations will be allowed, but work in this area must continue until Site 1 (Bridge No. 4.1) has been reopened to traffic.
