Bidders are hereby advised that on projects with structural steel girders, disc bearings, steel finger joints, overhead sign trusses and modular joints, fabricators shall provide in writing a fabrication schedule no later than the preconstruction meeting.

The schedule should include but is not limited to the following:

- Location where material will be fabricated (including coating locations)
- Project fabrication duration (including coatings)
- Project shipping durations
- Any projected breaks in the fabrication schedule
- Projected work schedule (days per week, hours per shift, shifts per day)
- The name and address of subcontractors involved in the fabrication
- The number of fabricated items

Steel fabrication shall not commence until MDOT has contracted with a steel fabrication inspection firm, all submittals are reviewed and stamped, a prefabrication meeting is held, and MDOT's fabrication inspection firm is on site.
