- Q3. Can we get the cut & fill areas for the cross sections?
- A3. The Earthwork Summary table on Working Number EQ-3, Sheet Number 24, shows the volume for the cut and fill broken out by the Working Sheet Numbers, and these areas can be visually seen on the Cross Sections. The successful bidder will also be provided CAD files for the project at Notice of Award.

- Q8. Will the contractors be allowed to access and utilize the previously constructed section of US 82 on the West end of the project to haul construction materials to the project?
