Bridge Replacements on SR 395 between SR 19 and the Winston County Line (Bridge Nos. 1.4 & 2.6), known as Federal Aid Project No. BR-0535-00(028) / 102504301 in Neshoba County.

The attention of bidders is directed to the Contract Provisions governing selection and employment of labor. Minimum wage rates have been predetermined by the Secretary of Labor and are subject to Public Law 87-581, Work Hours Act of 1962, as set forth in the Contract Provisions.

**Milestone – Interim Completion date.** Bidders are advised that this project carries a Project Milestone for each bridge that is an interim completion date for completion of all work necessary to reopen SR 395. This work includes signing of the detour, removal of the existing bridge, construction of the new bridge, all drainage items, earthwork, crushed stone, all 19-mm, 12.5-mm and 9.5-mm Asphalt, shoulder material brought up level with all 9.5-mm Asphalt, guard rail and the application of temporary stripe items. The Contractor will be assessed a penalty in the amount of **\$1,600.00** for each calendar day past the milestone completion date (for each bridge) until the Milestone Work is complete.

Bidders are further advised that the road shall not be shut down until production piles are on site and construction of the new bridge is ready to begin.

The Milestone Completion Date for **Bridge 1.4** shall be **150 calendar days after the date that the road is shut down as determined by the Engineer.** The Contractor will be allowed to work 24/7 to complete Milestone Work only.

The Milestone Completion Date for **Bridge 2.6** shall be **180 calendar days after the date that the road is shut down as determined by the Engineer.** The Contractor will be allowed to work 24/7 to complete Milestone Work only.

**Final Completion Date.** Final completion date to complete all remaining work required in the contract shall be **October 24, 2025** as referenced in Notice to Bidders No. 5483, Contract Time.
