Bidders are hereby advised of the following restrictions on the above captioned project.

The Contractor's attention is called to Working Number TCS-1, Sheet Number 4 of the scope of work documents for all work to be performed during the Old Highway 80 (Clay Street) Road Closure and the I-20 Ramp Over Highway 80 Ramp Closure.

#### Old Highway 80 (Clay Street) Road Closure:

The Contractor will be limited to two (2) weekend road closures which are NOT required to be consecutive.

Construction operations shall <u>not</u> begin before 6:00 P.M. on <u>Friday</u>, and must be complete and out of the roadway by 6:00 A.M. the following <u>Monday</u> morning.

All pertinent parties will be notified of each anticipated closure 10 calendar days in advance of each closure, and then further confirmation of the closure 5 calendar days in advance.

The Contractor will be responsible for contacting all pertinent parties for each closure. The MDOT will assist the Contractor in identifying all parties that need to be notified, but it will be the Contractor's responsibility to do the contacts.

The Contractor will be charged a fee of \$30,000 for each additional weekend road closure should the Contractor need more than the two (2) weekend road closures allowed to complete the work required.

#### I-20 Ramp Over Highway 80 Ramp Closure:

The Contractor will be limited to two (2) overnight ramp closures which are NOT required to be consecutive.

Construction operations shall <u>not</u> begin before 9:00 P.M. and must be complete and out of the roadway by 5:00 A.M. the following morning.

All pertinent parties will be notified of each anticipated closure 10 calendar days in advance of each closure, and then further confirmation of the closure 5 calendar days in advance.

The Contractor will be responsible for contacting all pertinent parties for each closure. The MDOT will assist the Contractor in identifying all parties that need to be notified, but it will be the Contractor's responsibility to do the contacts.

The Contractor will be charged a fee of \$100.00 for each full or partial sixty (60) minute period until the roadway is back in compliance with the restriction requirements stated above.

The Contractor will be charged a fee of \$800.00 for each additional overnight ramp closure should the Contractor need more than the two (2) overnight ramp closures allowed to complete the work required.
