Bidders are hereby advised that the existing traffic control items on the project will remain until such time the Contractor installs their devices. The handling, shifting or loading of the existing traffic items shall be coordinated with MDOT Maintenance personnel at the Tupelo District Office. Any costs associated with this work shall be included in pay item no. 618-A001, Maintenance of Traffic.

Bidders are further advised that during daytime operations, southbound traffic may be diverted onto the on/off ramps if the following conditions are met. The Contractor shall submit a Traffic Control Plan for approval by the Project Engineer prior to shifting traffic. The Traffic Control Plan shall also meet the requirements of General Note 14 on Sheet Number 3 (Working Number GN-1) as well as other requirements in the Contract Plans and Standard Specifications. Delays and/or costs while the Traffic Control Plan is being reviewed or from rejection of the Contractor's Traffic Control Plan will not be considered. The Contractor will be required to protect the roadway and traffic regardless of if traffic has been shifted onto on/off ramps.
