Bidders are hereby advised that when placing centerline thermoplastic audible stripe, the Contractor **WILL NOT** be allowed to place transverse bars after the placement of permanent stripe as outlined in Special Provision No. 907-626-9. In areas with centerline audible thermoplastic traffic markings, the Contractor will be required to place Thermoplastic Audible Traffic Stripe, Centerline Skip – Passing Zone and/or Thermoplastic Audible Traffic Stripe, Centerline Skip – No-Passing Zone prior to placing 6” Thermoplastic Double Drop Traffic Stripe, Skip Yellow and/or 6” Thermoplastic Double Drop Traffic Stripe, Continuous Yellow.
