Bidders are hereby notified of the following U.S. Fish and Wildlife Service commitments for this project.

All in stream work **SHALL** be limited to between June 15 through February 15 to avoid impacts to spawning and young-of-year Gulf Sturgeon.

Bridge demolition over the water **SHALL** be limited to between June 15 through February 15 to avoid impacts to spawning and young-of-year Gulf Sturgeon. If temporary platforms are required, they will be constructed immediately prior to bridge demolition and removed as quickly as possible.

Bidders are hereby notified that if a temporary work bridge is required, it will be constructed on pilings so flow and fish passages are minimally impacted. **NO CULVERT STREAM CROSSINGS** will be allowed.

Instream logs will be left in the river channel, because they provide basking habitat for the federally threatened ringed map turtle. If instream logs need to be removed, they will be moved downstream and/or into the main channel so that they are retained within the waterway for use by the ringed map turtle.

For the purposes of this contract, “in stream” work does **NOT** include working from a barge, provided there is **NO** disturbance to the channel below that would have an impact to the spawning and young-of-year Gulf Sturgeon.
