**Milestone – Interim Completion date for Project Number STBG-0052-02(029) / 109697301 – Yalobusha County.** Bidders are advised that this project carries a Project Milestone that is an interim completion date for completion of all work necessary to reopen SR 32 over Grenada RR Bridge (#67.3). This work includes Removal of Bridge Deck, Hydrodemolition, Bridge Deck Overlay Concrete, Bridge Repair, Removal of Bridge Deck, Per Plans, Bridge Repair, Endwall Repair, Per Plans, Removal of Joint Material, Joint Repair Without Epoxy, Preformed Joint Seal, Type I, and Saw Cut, Type I as per the plans on Sheet No. 8003. The Contractor will be assessed a penalty in the amount of **\$3,000.00** for each calendar day past the milestone completion date until the Milestone Work is complete.

The Contractor shall notify the following fifteen (15) days prior to closing the roadway:
